DIRECTIONS FOR USE

COLOR MAXX is a fertilizer product for use on all plant material. It is optimized for use with fertigation systems but may also be used in foliar applications. COLOR MAXX may be added to any FERTI MAXX fertility product, most other fertilizers, and most agricultural chemicals after conducting a jar test for compatibility. Always treat a small test area with any experimental blends to determine potential phytotoxicity before making general applications. Use year round, effective in cool and hot weather.

APPLICATION RATES / INTERVALS

FERTIGATION SYSTEMS: Add 1 gallon of COLOR MAXX for every 10,000 sq. ft. of landscape.

FOLIAR APPLICATIONS: Mix 1 ounce of COLOR MAXX per gallon of water and apply evenly. Repeat until desired results are achieved. Do not exceed the 2 ounces per gallon maximum rate.
