DIRECTIONS FOR USE

FERTI-MAXX TURF is a fertilizer product for use on all plant material. It is optimized for use with fertigation systems but may also be used in foliar applications. FERTI-MAXX TURF may be added to any FERTI-MAXX fertility product, most other fertilizers, and most agricultural chemicals after conducting a jar test for compatibility. Always treat a small test area with any experimental blends to determine potential phytotoxicity before making general applications. Effective in warm and hot weather.

APPLICATION RATES / INTERVALS

FERTIGATION SYSTEMS: Use 1 pound per every 2,000 square feet. Refill or apply every 4 to 6 weeks. Amount can be increased or decreased depending on desired results and plant needs.

HAND APPLICATIONS: Mix 1/2 Tablespoons per gallon of water and apply by spray or watering can for outdoor plants. Mix 1/4 teaspoon per gallon for indoor plants. Apply every 1 to 2 weeks.

WARNING- Application of fertilizing materials containing molybdenum (Mo) may result in forage crops containing levels of molybdenum (Mo) which are toxic to ruminant animals.
