DIRECTIONS FOR USE

Use HYDRO-CLEANSE when high pH or mineral issues may be preventing nutrient uptake, or to clear drip emitters when clogged. Due to the low pH of this product, it is recommend to not mix with any calcium based or high pH products. Please conduct a jar test or contact EZ-FLO prior to combining with other substances. When using HYDRO-CLEANSE to clean irrigation systems, do not let pH at the emitter fall below 6.0

RATES / INTERVALS EZ-FLO MAINLINE SYSTEMS

For emitter cleaning, add up to 20% of the tank capacity with HYDRO-CLEANSE, filling any remaining tank capacity with water, and use the fast setting. Repeat biweekly until results are achieved.

For general pH adjustment and nutrient release, fill 50% to 100% of the tank capacity with HYDRO-CLEANSE, filling any remaining tank capacity with water, and use the Slow, #1, or #2 setting. DO NOT USE THE FAST SETTING. For more information refer to the charts on our website.
