DIRECTIONS FOR USE

MAXX INSECT repellent uses a proprietary formulation to repel the most common nuisance insects including but not limited to: fleas, ticks, ants, and mosquitoes. MAXX INSECT may be used safely on all landscape materials when used at the recommended rates, providing a safe barrier against pests. Not for use on food or feed crops. MAXX INSECT may be applied in residential or commercial, pre or post planting. Infestation level, frequency, and timing of application will affect results. APPLICATION RATES / INTERVALS

FERTIGATION / INJECTION SYSTEMS: Apply at a rate of 0.25 gallons (32 ounces) per 32,000 sq. ft. per month.

HOSE END SPRAYER APPLICATION: Fill container and set application rate to 1 ounce.

PUMP SPRAYER APPLICATION: Use 1 ounce per gallon of water, each mixed gallon of solution will treat up to 1,000 sq. ft. For heavy infestations, increase any of the above rates by 4 times for expedited response.

SHAKE WELL BEFORE USING

STORAGE INFORMATION:

Keep container tightly closed. Store in a cool, dry location, away from direct sunlight or where freezing is possible. Failure to follow storage guidelines may lead to product degradation.
