DIRECTIONS FOR USE

RHIZO MAXX is for use on all plant material. It is optimized for use with fertigation systems but may also be used in foliar applications. RHIZO MAXX may be added to any FERTI MAXX fertility product, most other fertilizers, and most agricultural chemicals after conducting a jar test for compatibility. Always treat a small test area with any experimental blends to determine potential phytotoxicity before making general applications.

APPLICATION RATES / INTERVALS

FERTIGATION SYSTEMS: Add 1 quart of RHIZO MAXX for every 10,000 square feet of landscape.

FOLIAR APPLICATIONS: Mix 1 ounce of RHIZO MAXX per gallon of water and apply evenly. Repeat until desired results are achieved. Do not exceed the 2 ounces per gallon maximum rate.
